Thank you for your Feb. 15 letter and its good news that you are moving forward in the project of organizing a chapter there in Sult (Ontario).

By this time you will have had your scheduled Feb. 16 planning meeting which we certainly hope developed a lot of interest and laid the ground-work for a larger scale organizational meeting.

Under separate cover we are sending you 100 copies of "Why It's Great To Be A arbershopper" and "Just What Is Barbershop Harmony" without charge. Regretably, we are still not set up to aid organizing groups to the extent that we should (I am referring now to music) but will also have sent to you, again without charge, 20 copies each of "The Old Songs", "You Tell Me Your Dream" and "Daisy-Annie Rooney" which I hope will be enough to get you started.

Actually, a chapter, the Soo, would under present district boundaries be assigned to the Ontario District. (As you know, however, districts are set up purely for administrative purposes and contests, and there would certainly be nothing at all to interfere with your receiving plenty of assistance from the Michigan District which is closer to you and enjoying inter-chapter activities with any of their group and even with some of the Land O' Lakes District chapters which fall in the upper Peninsula of Michigan. You will note I am sending a copy of this letter to Wilbur Crawford who is President of the Cheboygan, Michigan Chapter, which is the closest to you and which I am sure would be glad to offer you any assistance they can.

Checking the file I note that my November 24 letter states that we were sending you a complete prospect's kit which I assume you have received. If not, be sure to let me know and we'll get one off to you so that you'll have full information.

How about letting us have a report on your Feb. 16 meeting, Ted, and any other news you can pass on at this time? Good luck and good harmony.

As soon as you have had an opportunity to look over the material contained in this kit if there is anything which is not completely clear or about which you would like to have additional information please don't heistate to let us hear from you. In any event please keep us and your District Officers posted from time to time on your progress and of course be sure to tell us what we can do to be of further assistance.

As your Charter Petition bears all of the necessary signatures, we are setting up our Sault Ste Marie Chapter as of this date.

The enclosed bulletin describes the charter membership arrangement and outlines the material and supplies being shipped to your chapter in your care under separate cover.

Also enclosed with this letter are a few address change cards, price lists, order blanks and guides for newspaper articles.

By virtue of your now being a duly chartered Chapter of SPEBSQSA within the boundaries of the Michigan District, your chapter is automatically a member of that District Association of Chapters. The District Secretary is Louis R. Harrington, 2361 First National Bldg., Detroit 26, Michigan and the District President is John Comloquoy Jr., 770 Woodlawn, Jackson, Michigan. Your Area Counselor is Charles E. (Ted) Spry, 528 Lake St. Sault Ste. Marie, Ontario, Canada. You will undoubtedly be hearing from one or more of them in the near future.

Congratulations to both your Chapter President and your self on your election to the key offices in this new chapter. We know that you and your fellow chapter members are

going to find your membership in our Society a most rewarding one. The fun, fellowship, and fulfillment you will experience in sharing your love of singing with others will soon show that our Society is indeed unique and offers a brand and degree of fellowship which is simply not available in any other organization.


